FRIENDLY REMINDERS

SPEEDING

Out of respect and for the safety of our community, please keep your speed below 25mph while driving through the subdivision.

TRASH CANS

According to the bylaws, "trash receptacles shall be maintained in garages and shall not be permitted to remain elsewhere on the unit or common elements."

TREE TRIMMING

Homeowners are responsible for maintaining the trees on their property, including those along the sidewalks and berm. Tree branches should not interfere with or impede people walking on the sidewalks. Trees in the common areas have been trimmed accordingly.

SNOW REMOVAL

As we start the transition into fall we wanted to put out a reminder that homeowners are responsible for clearing the snow off driveways and the sidewalks adjacent to your property within 24 hours of a snowfall greater than one inch. This is a township ordinance and is enforced.

STREET LIGHTS

Street lights throughout the community are maintained by Pittsfield Township/DTE. If you notice a light is out, please contact the HOA board or Pittsfield Township at (734)822-3134. Each pole has a unique identification number (in yellow) - you will need to provide that number for the light to be repaired.
